## SCHOOL ORGANISATION

Pupils at New Haw benefit from generous support and leadership from highly qualified, enthusiastic teachers and assistant teachers. The role of the assistant teacher is, as the name suggests, to work alongside the class teacher delivering the curriculum and meeting the needs of individual pupils. When staff are absent for short periods of time, the children are taught by an assistant teacher who knows the class organisation and understands the needs of individual pupils.

The school is organised into 12 classes with three classes in each year group. All classes are mixed ability.

### Child Protection

The Head of School is the Designated Safeguarding Lead (DSL) at New Haw. 7 further staff members are Deputy Designated Safeguarding Lead's. Details and guidance for all issues relating to child protection are outlined in the school's Child Protection Policy.

### Disclosure and Barring Service

Everyone working with children in the school, whether employed staff or volunteers, must have a satisfactory Enhanced Disclosure issued by the Disclosure and Barring Service (DBS). This is undertaken prior to appointment and all employment is subject to satisfactory clearance being obtained.

### School Day

The school is in session from 8.45am to 12.00. with a 15 minute break mid-morning and from 12.50pm to 3.25pm in the afternoon. For those parents who need childcare outside of school hours, both an early morning club and an after-school care facility are available for pupils.

## **CURRICULUM**

The curriculum at New Haw is broad, balanced and well planned, giving each child the opportunity to work at an appropriate level on tasks designed to promote success.

All the children in the school follow the National Curriculum. This includes mathematics, English, science, history, geography, computing, art and design, design and technology, music, French and PE. Religious education and personal, social, health and economic education (PSHE) are also taught. Children have access to high quality ICT resources . These include:

- A set of 64 Chromebooks to be used for cross-curricular work in classrooms.
- A set of 32 iPads to be used for cross-curricular work in classrooms.
- An interactive screen in each room to enhance teaching and learning.
- Classroom computers and computer banks around the school.

### **English**

The overarching aim for English in our school is to promote high standards of literacy by equipping pupils with a strong command of the written and spoken word, and to develop their love of literature through widespread reading for enjoyment.

Language is at the centre of children's learning. In both spoken and written form it is the tool for the communication of ideas, the medium by which we think and the means through which we establish personal relationships. Language is the gateway to other subjects and is learned indirectly through all subjects, as well as through English. Children are taught English for at least one hour a day.

### **Reading**

The programmes of study for reading consist of two dimensions:

- word reading
- comprehension (both listening and reading)

Children have access to a wide range of reading resources and opportunities. The school uses the Oxford Reading Tree scheme and children are encouraged to take home their reading book and planner every evening. In addition, we have a well-stocked school library that is supplemented regularly with modern fiction and up-to-date information books. Sets of group reading books are available for each year group.

### **Writing**

The programmes of study for writing are constructed similarly to those for reading:

- transcription (spelling and handwriting)
- composition (articulating ideas and structuring them in speech and writing).

Pupils are taught to consciously control their speaking and writing, and to use Standard English. Spelling, grammar, punctuation and handwriting are taught in discreet weekly lessons, and are reinforced during daily English lessons.

Children write for a variety of purposes and audiences. Through modelled writing, they are taught skills that enable them to learn the craft of writing and pupils are encouraged to draft and revise work with a partner or their teacher. A fully cursive, joined handwriting style is taught.

## **Maths**

Children are taught maths for one hour per day. We aim to provide them with a foundation of basic skills and concepts, which will enable them to tackle practical problems, as well as analyse and communicate information. Additional help is made available for pupils who require support with this subject.

## **Science**

Key scientific concepts and skills are taught to enable children to understand the world around them. We encourage them to use scientific methods of investigation, to make successful, disciplined enquiries and use their ideas to solve relevant problems. These methods leave scope for the imagination and the systematic development of ideas and analysis of results.

We believe that good science education involves children enjoying themselves and showing curiosity, perseverance, open mindedness, self-discipline and ingenuity.

## **Computing**

As part of the national curriculum, children in every year group will be given the opportunity to explore programming, helping them to develop a deeper understanding of how computers work.



ICT is used in all subjects across the curriculum and we are constantly upgrading our software and facilities for the benefit of our pupils.

## **Religious Education**

The general religious ethos in the school is non-denominational Christianity. In assemblies, as in class teaching, moral and religious education is allied to the Christian faith, although children also learn about other religions of the world as part of the RE programme. Most parents of other faiths are happy to let their children take part in the religious education programme offered by the school: where parents wish to exercise their right to withdraw their children from school assemblies, for example, their children have the opportunity to study their own religion quietly in the library.

The major Christian festivals of Christmas and Easter are celebrated by the whole school.

## **Physical Education**

Children at New Haw enjoy a weekly programme of physical activity, which includes: indoor PE; gymnastics or dance and one hour of games on the school field or playground. In addition to this, pupils in year 4 are offered a swimming course at a local pool.

The school offers a programme which includes football and netball, tag rugby and hockey in the autumn and spring terms, and athletics, rounders, cricket, tennis and outdoor adventure activities in the summer months. The school is a member of WASPS, (Woking Area Sports Primary Schools) and children regularly compete with other schools in the association.

**Please do not have your child's ears pierced during term time, as pierced earrings must be removed before PE lessons.**

## **History**

The teaching of history at New Haw enables children to reflect on human achievement, consider moral dilemmas faced by people in the past and find out about other cultures and how societies, including our own, develop.

Our children are encouraged to use enquiry and investigation to develop their awareness of the passage of time and history's effect on the present. They learn to present information in a variety of ways and use a wide range of resources. Work is related to events in British history and broadens to include other civilisations. Much work is based on the children's first-hand experience and we encourage their participation in school visits, which further enhance school-based learning

## **Geography**

Geography at New Haw is about finding out about the world around us, how it was formed, how it has developed, how to sustain it and how to improve it. It is also about studying how mankind has adapted to survive and progress in its natural environment all around the world.

All children are naturally fascinated with the world around them and how it works. We try to foster this enthusiasm by teaching the subject through an enquiry-based, hands-on experiential approach, thus enabling each child to become a geographer.

## **French**

Pupils in years 3, 4, 5 and 6 enjoy a wide range of learning activities in this subject, designed to promote a positive attitude and a lifelong interest in learning and using a foreign language. Where possible they are taught by a native speaker.

## **Special needs**

Some children may have a greater difficulty in learning than the majority of children their age, or a disability which might hinder them from making use of education facilities. These children are regarded as having special educational needs. At New Haw we work hard to try to ensure the best possible outcomes for all of our children. Our class teachers work closely with Mrs Rachel Dempsey, our special educational needs co-ordinator (SENCO) to identify and meet the children's needs as effectively as we can.

With parental permission we may seek advice from outside agencies, such as Educational Psychology, Occupational Therapy, Speech and Language Therapy, CAMHS etc.

## **More Able Children**

For children who are identified as having outstanding abilities, we are able to offer a broad spectrum of activities to extend their learning and challenge their thinking. Our teachers work hard to ensure that that children are identified and supported in this area.

## **Sex Education**

During the course of their studies the children learn about various aspects of sex education - not in isolation, but integrated into science and personal, social, health and economic education (PSHE). In the lower school, children are introduced to simple anatomy and the growth and changes that occur from conception to childhood. The upper school course covers sexual intercourse, birth, maturation, menstruation and personal hygiene. Children are mostly taught in mixed groups but one of the female teachers will talk to the girls about the practical details of coping with menstruation. Parents have the right to withdraw their children from sex education lessons. If you have any concerns please talk to your child's class teacher.

## HOME LEARNING

Homework is an important aspect of education and we are grateful for your part in helping your child understand this and for giving appropriate help in the way it is managed.

We appreciate your continued support and involvement.

### Google Classroom

Homework will be set and submitted via Google Classroom. Your child's log in for Google Classroom can be found in their planner.

### Doodle Maths

Doodle Maths will now form part of the children's weekly homework and the expectations of use are included below. This will vary depending on which year group your child is in.

Year 3 expectations – 1 assignment

Year 4 expectations – 1 assignment and 2 days of 'X questions a day'\*

Year 5 & 6 expectations – 1 assignment and 3 days of 'X questions a day'\*

*\*The 'X questions a day' will be personalised to your child. Some may have 6 a day while others have 10 a day.*

### Reading

All children are expected to read to an adult, outside of school, at least 5 times a week and have this recorded in their planners (See page 6 of planner). Planners will be monitored weekly. In addition, children will be heard read at least once a week in school by their teacher or assistant teacher. It is vital that during these times, both in and out of school, children have opportunities to discuss their reading, commenting on vocabulary, making predictions and giving opinions. Children who read regularly to an adult make more progress than those who do not.

## IMPORTANT

If your child regularly has problems with home learning please come to see us. Never hesitate to help your child, remember you are their permanent teacher!



## PUPIL PLANNERS AND STATIONERY

At the start of each academic year, parents are required to purchase a school planner for their child. The planners have been designed to act as a great resource for pupils and parents alike – there is a wealth of information within them to support the year 3 curriculum. Planners are also used as your child's reading record. Please ensure you record their home reading each night, stating the name of the text and the number of pages they read. The children additionally use the planners to record additional homework and other things they need to remember. Your child's class teacher may also use the planner to send a message home to you and it is an ideal way for you also to send messages into school. Please take time to go through the planner with your child. If the planner is lost, replacements can be purchased from the school office.

Each year we provide the children with all the stationery they need for the academic year. This includes: pens, pencils, rulers, rubbers, pencil sharpeners, whiteboard pens, glue sticks etc. This keeps desks clear from pencil cases and means parents do not have to buy any stationery for their child.

We ask parents for a one-off payment of £15. This covers a planner and all stationery. We are able to buy stationery in bulk at a reduced cost so that this is cost effective for parents.



## **PARENTAL INVOLVEMENT**

We enjoy a warm and friendly relationship with the parents of our pupils. We operate an 'open door' policy and seek your interest and support at all times. In addition to the extensive programme of formal opportunities for liaison listed below, please remember that you are welcome to contact us at any time with any concerns you may have.

### **School Website ([www.new-haw.surrey.sch.uk](http://www.new-haw.surrey.sch.uk))**

Please find time to visit our school website, which can be found at the above address. The site includes a wide variety of information about school activities as well as administrative links, e.g. current school newsletter and recent letters distributed to parents.

### **Parents In Partnership (PiP)**

The PiP group (one parent from each class) meet regularly with the Head Teacher and senior team to discuss matters of school policy and share ideas/concerns which may arise from time to time. If you are interested in joining this group, please volunteer to represent your class.

### **Home/School Agreement**

As part of the admissions process parents are requested to read and sign the Home/School Agreement. This agreement clearly sets out key expectations of how home and school will work together to provide the best possible education for your child. A copy of the agreement is on the front section of the school planner.

### **Curriculum Meeting**

At the beginning of each academic year, parents are invited to attend a curriculum meeting. These are usually held via Zoom. The purpose of this meeting is to introduce staff and to share information about the curriculum and expectations of parental support for pupils during the year.

### **Show and Share**

'Show and Share' afternoons provide a regular opportunity for children to show and share their work after school. Pupils are proud of their work and enjoy the opportunity to share their achievements with parents, grandparents, carers and siblings.

### **Parents' Evenings**

Parents' Evenings are held twice a year in the autumn and spring terms. These evenings provide an important opportunity for staff and parents to discuss issues relating to pupil progress. We encourage children to attend these appointments, wherever possible, with their parents.

### **Celebration Evening**

This is usually held late in the summer term. The evening is designed as an opportunity to celebrate the work of staff and children at the end of the academic year.

### **Other Events**

Parents are invited to other events for a range of purposes e.g. class assemblies, sports day, our leavers' presentation and the Christmas fayre. Such events are by invitation, and we will keep you informed of these as they occur.

### **Pastoral Care**

As in most schools in the primary sector, the adult closest to your child is the class teacher and with him or her lies the main responsibility for the welfare of your child. We are committed at New Haw to providing a caring environment and staff are watchful for any signs of a change in behaviour. If we have any concerns you will be advised immediately and we would be grateful if parents could inform us of any change in circumstances which may be relevant to their child's school life.

### **Safeguarding Children**

New Haw Community School follows the National Children's Procedures for safeguarding and promoting the welfare of children. The outcomes for children are placed firmly at the centre of all policies.

New Haw is committed to ensuring the welfare and safety of all children in school. All Surrey schools follow the SCC Safeguarding Children Board procedures. The school will, in most circumstances, endeavour to discuss all concerns with parents about their children. However, there may be exceptional circumstances when the school will discuss concerns with Social Care and/or the Police without parental knowledge (in accordance with Child Protection procedures). The school will, of course, always aim to maintain a positive relationship with all parents. The school's child protection policy is available on request.

### **Behaviour**

At New Haw we encourage a spirit of friendliness and mutual respect amongst pupils and staff. Discipline is firm, but not based on regimentation or fear of punishment, rather an expectation of hard work and sensible behaviour that naturally leads to self-discipline. We nurture a very positive school climate with a system of rewards based on a balance between extrinsic rewards (for example, stickers, certificate) and a desire to help children appreciate the intrinsic satisfaction to be gained from work well done and relationships well conducted.

Any misbehaviour is dealt with by the class teacher in the first instance. If the child's behaviour continues to cause concern, the class teacher or a senior member of staff will contact parents to discuss the issue.

## **ATTENDANCE**

Attendance has a very high profile in our school and each week the class with the best attendance is announced in assembly. Pupils who manage to achieve 100% for the whole year are recognised with a certificate in July.

### **Holiday in term time**

In accordance with Government guidelines, permission will not be granted for a holiday taken during term time. It is only under “exceptional” circumstances, and prior agreement with the Head Teacher that an absence will be authorised.

## **AUTHORISED/UNAUTHORISED ABSENCE FROM SCHOOL**

The Government now requires all schools to report annually on figures for unauthorised absence. An unauthorised absence occurs when a child is absent from school with no letter of explanation/telephone call to explain the absence or when the reason for absence is invalid.

### **Authorised and unauthorised absence 2022-2023**

Sessions missed due to authorised absence = 3.41%

Sessions missed due to unauthorised absence = 0.88%

### **Medical**

Unfortunately, children can become unwell or have an accident at school. In this situation, our first aid trained staff will make an assessment and call the named parent on file if we feel your child needs to go home. In the event of a minor head bump, a text will be sent home to advise parents. It is very important therefore that you inform the school office if there are changes to contact information.

If your child is unable to come to school due to illness, or indeed for any reason, please contact the school office by telephone, e-mail or in writing on the first day of absence. Should your child require medication at school, a Pupil Medication Request Form must be completed. This document is available from the school office or may be downloaded from the school website.

### **General**

- Children should not arrive at school before 8.30 a.m, when they can go straight to their classrooms.
- Sweets and chewing gum are not to be brought to school. Chocolate biscuits are allowed as part of a packed lunch, but not packets of sweets. Children may bring fruit or vegetables to eat at break-time.
- Children are encouraged to bring water, in a water bottle, into class.
- “Featherlight” balls only are allowed on the school playground. These are light sponge balls which do not pose a safety threat to other children.
- No money should be brought to school unless it has been specifically requested. If money is brought in, it should be in a sealed labelled envelope.
- The only items of jewellery permitted are, small, stud earrings (1 per ear) and watches.

## **EXTRA-CURRICULAR ACTIVITIES**

### **CLUBS**

The school offers a very wide range of extra-curricular activities throughout the year. These vary according to the seasons and the availability of outside providers. Details of current provisions can be found on the school website at [www.new-haw.surrey.sch.uk](http://www.new-haw.surrey.sch.uk) under "School Clubs". A small charge is made for most clubs. The programme usually includes such activities as football, art/craft, drama and cookery. Our sports teams play fixtures against other schools and we take part in inter-school rallies, netball, rounders and cross country.



### **MUSIC**

The school choir meets weekly and participates in local music events during the year. Surrey Arts Music Service operate an excellent scheme, offering a very wide range of instrumental tuition for children.

### **LARKS EARLY MORNING CLUB**

To support parents who require childcare for early mornings, the school provides an early morning club daily from 7.45a.m. The charge is £6.00 per session, which must be pre-booked and pre-paid half-termly in advance.

### **OWLS AFTER SCHOOL CLUB**

For those parents that require after school care for their children, we are pleased to be able to offer Owls club on our premises. We have two sessions available; a shorter session from 3.25 p.m.- 4.30 p.m. and a longer session which finishes at 6.00 p.m. The cost for these sessions are £9 and £14 respectively. This facility must also be pre-booked and pre-paid half-termly in advance.

### **CHARGING FOR EDUCATIONAL VISITS/THEATRE GROUPS ETC**

The Education Reform Act states that schools are prohibited from charging for any form of educational activity which takes place during the school day. The act does allow schools to request a voluntary contribution to support such activities. However, if insufficient funds are received from parents, an educational visit may have to be cancelled. No child at New Haw School will be excluded from an educational day visit because of an inability to make a voluntary contribution.

### **PARENT TEACHER ASSOCIATION**

Parents of children attending New Haw School are automatically members of the Parent Teacher Association. Each year a new committee is elected at the AGM usually held in early October. The Parent Teacher Association works hard to raise money for the school, and they also run social events for both parents and children. Please offer them your support. You do not have to be on the committee; there are all sorts of ways in which you can help.



## SCHOOL MEALS

At New Haw we aim to ensure healthy eating for all pupils through the provision of a well balanced school lunch, served in a warm, welcoming dining environment. It is important to establish good eating habits that can last a lifetime; to teach children about the importance of not only their physical well-being but how food can affect their mood, temperament and energy levels.

We offer a choice of up to 6 different options on a daily basis. This choice will ensure that children get a meal that they enjoy and have chosen themselves. We can cater for a wide variety of dietary needs including halal, vegetarian and gluten-free options. A "Fun Friday" option is also available where children who normally have a packed lunch can have a school meal.

The cost of a school meal is £2.70 per day, which must be paid in advance on a weekly, half-termly or termly basis. Payment for school dinners can be made online at <https://scopay.com/newhaw> (see link on our website). Cheques should be made payable to Surrey County Council.



## PACKED LUNCH

Packed lunches can also be brought to school. They must be provided in a plastic, non-breakable container which is clearly named with your child's name. Due to possible allergies, we request that no nuts or nut products are brought into school.

## HEALTHY SNACKS IN SCHOOL

We encourage children to bring in a healthy snack at break time, ideally fruit. Crisps, chocolate, cakes and sweets are not permitted during break time.

## MILK

## WATER

Children may bring in a bottle of water each day.

## SCHOOL UNIFORM

At New Haw we strongly believe that wearing smart school uniform encourages our children to take pride in themselves and in our school community. ## SCHOOL BAG

All pupils are requested to use a school bag available from our uniform suppliers.

## SHOES

Please provide 'sensible' footwear (shoes or sandals). For girls, platform soles and/or high heels can be dangerous in school and must not be worn. If wellingtons are worn to school in wet weather, children must have other footwear to change into during the day. **Trainers may be brought to school for wear during playtime or outdoor games only.**

## GENERAL

Hair any longer than shoulder length must be tied back for school. No hair cut less than Grade 2 or any tram lines/extreme hairstyles are acceptable. This prepares children for the requirements of Secondary School.

For art and craft work in school the children really need some sort of overall. An old, adult's shirt, put on back to front, is excellent for the purpose. We have found the paint to be less washable than the manufacturers claim.

## IMPORTANT

**PLEASE ENSURE THAT EVERY ITEM WORN TO SCHOOL IS MARKED WITH YOUR CHILD'S NAME**

As in all schools, we have a constant problem with unmarked clothing. Please try to encourage your child to see that his/her name is in all clothing which he/she is likely to remove. It is frustrating for you and very time-consuming for us to try to re-unite child and clothing. Any clothing not claimed at the end of term will be disposed of.

## **ADMISSIONS POLICY**

### **Academic Year 1st September 2024 - 31<sup>st</sup> August 2025**

This document sets out the determined admission arrangements for New Haw Community School ("The School") for 1<sup>st</sup> September 2024 – 31<sup>st</sup> August 2025.

The school participates in the local authority co-ordinated admissions scheme where an equal preference system operates (for details see LA website).

The current Published Admission Number (PAN) is 90 children into Year 3.

Children with an EHCP, **which names New Haw Community School**, will be admitted. The number of places available for other children will be reduced by the number of children with an EHCP which names the school.

Priority for admission arrangements from 2024 will be as follows:

#### **First Priority: Looked after and previously looked after children**

Within the admission arrangements looked after and previously looked after children will receive the top priority for a place. Looked after and previously looked after children will be considered to be:

- children who are in the care of a local authority or provided with accommodation by a local authority in accordance with Section 22 of the Children Act 1989, e.g. fostered or living in a children's home, at the time an application for a school is made; and
- children who have previously been in the care of a local authority or provided with accommodation by a local authority in accordance with Section 22 of the Children Act 1989 and who have left that care through adoption, a child arrangements order (in accordance with Section 8 of the Children Act 1989 and as amended by the Children and Families Act 2014) or special guardianship order (in accordance with Section 14A of the Children Act 1989); and

children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted. A child will be regarded as having been in state care outside of England if they were accommodated by a public authority, a religious organisation or any other provider of care whose sole purpose is to benefit society. The parent/carer will need to provide evidence to demonstrate that the child was in state care outside of England and left that care as a result of being adopted

#### **Second Priority: Exceptional social/medical need**

Occasionally there will be a very small number of children for whom exceptional arrangements apply which will warrant a placement at a particular school. Supporting evidence from a professional will be required such as a doctor and/or consultant for medical cases or social worker, health visitor, housing officer, the police or probation officer for other social circumstances. This evidence must confirm the circumstances of the case and must set out why the child should attend the school and why no other school could meet the child's needs.

Providing evidence does not guarantee that a child will be given priority and in each case a decision will be made by the Governing body of New Haw Community School based on the merits of the case and whether the evidence demonstrates that a placement should be made at one particular school above any other.

Places may be allocated under this criterion when places are first offered at a school and the Local Authority may also ask schools to admit over their Published Admission Number at other times under this criterion.

### **Third Priority: Children attending The Grange Community Infant School**

Pupils who are currently in year 2 at The Grange Community Infant School will be admitted under this priority.

### **Fourth Priority: Siblings not admitted under 3 above**

A sibling will be considered to be a brother or sister (that is, another child of the same parents, whether living at the same address or not), a half-brother or half-sister or a step-brother or step-sister or an adoptive or foster sibling, living at the same address.

A child will be given sibling priority if they have a sibling at New Haw Community School or The Grange Community School, and the sibling is still expected to be on roll at either school at the time of the child's admission. This will apply both at the initial allocation of places and also when prioritising the waiting list. Giving siblings priority has the effect of maximising the opportunity for children in the same family to be educated at the same school or at a school on a shared or adjoining site.

If within this category there are more applicants than places available, any remaining places will be offered to applicants who meet this criterion on the basis of proximity of the child's home address to the school.

### **Fifth Priority: Children of Staff**

Priority will be given to the children of staff where the member of staff **has been employed at the school for at least two years** at the time at which the application for admission to the school is made.

### **Sixth Priority: Any other children**

Remaining places will be offered on the basis of nearness to the school measured in a straight line from the address point of the pupil's house, as set by Ordnance Survey to the nearest official school gate for pupils to use.

Where two or more children share a priority for a place, e.g. where two children live equidistant from a school, New Haw Community School will draw lots to determine which child should be given priority.

From a school, New Haw Community School will draw lots to determine which child should be given priority.

### **Home Address**

Within the admission arrangements for community and voluntary controlled schools the child's home address excludes any business or childminder's address and must be the child's normal place of residence. It also excludes any relative's address unless the child lives at that address as their normal place of residence. In the case of formal equal shared custody it will be up to the parents to agree which address to use. In other cases it is where the child spends most of the time. All distances will be measured by the computerised system maintained by Surrey School Admissions.

### **Waiting lists**

Where there are more applicants than places available, waiting lists will operate for each year group according to the oversubscription criteria for each school and without regard to the date the application was received or when a child's name was added to the waiting list.

Waiting lists for the initial intake will be maintained until the last day of the autumn term when they will be cancelled. Parents wishing to remain on the waiting list after this date must write to the school by 31<sup>st</sup> December 2024, stating their wish and providing their child's name, date of birth and the name of their child's current school. After 31<sup>st</sup> December 2024, parents whose children are not already on the waiting list but who wish them to be so must apply for in-year admission. Waiting lists for all year groups will be cancelled at the end of each academic year.

From 1<sup>st</sup> September 2023 in-year admissions for Years 3-6 will be administered using the criteria above.

### **Appeals**

If a place is not offered at the school there is a right to appeal to an independent panel. Contact is through the Surrey Schools Appeals Service. ### **Out of Chronological Year Admissions**

Applicants may choose to seek a place outside of their child's chronological (correct) year group.

Whilst there is no statutory barrier to children being admitted or educated outside of their chronological year group, if such an application is made, it is for the school's admissions authority to decide whether to agree to such a request. Any such decision will take into consideration the circumstances of the case and what is considered to be in the best interests of the child.

Any such applications must state clearly why they feel admission to a different year group is in the child's best interest and provide what evidence they have to support this.
